## **Background:**

Based on the January 29 meeting of the Ad Hoc By-law Review, a survey was created to solicit feedback on the Noise By-law, Littering By-law, Property Standards By-law, and Clean and Clear Yards By-law.

The survey results are varied, some respondents believing the by-laws and enforcement too strict, but the majority responded that the by-laws either work well or are not strict enough.

A common theme in the additional comments is a lack of enforcement, proactive or reactive.

Attached is the detailed Public Engagement Report, including all additional comments.

## **Conclusion:**

The By-law Review Survey offers valuable feedback on the way residents view the City By-laws. All feedback will be considered during the review process.

# Background & Engagement

## Background

During the Oct. 28, 2024 council meeting, a motion was made to establish an ad hoc committee to review the littering, property standards, clean yards and other public order and community standards by-laws. The ad hoc committee was formed in December and staff were engaged to oversee the project. Under the direction of the committee, a public engagement strategy was developed and staff launched an online survey in February to gain the community's input on the existing littering, property standards, clean yards and noise by-laws.

## Objectives

The primary goal of the review was to ensure that the by-laws are practical, enforceable and aligned with the expectations of the community. By addressing the specific needs and concerns of residents, the committee aimed to enhance the effectiveness of these by-laws in promoting safe, clean and well-maintained properties, regulate noise to foster a harmonious environment. Through this process, the committee hopes to provide clear, actionable recommendations that improve compliance, clarity and overall community satisfaction.

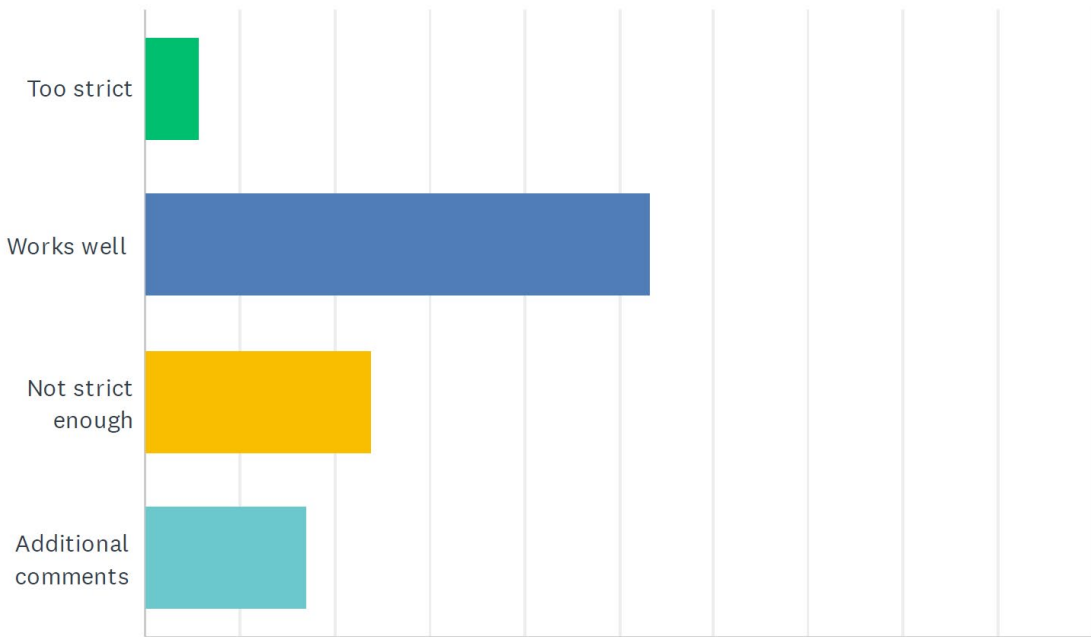

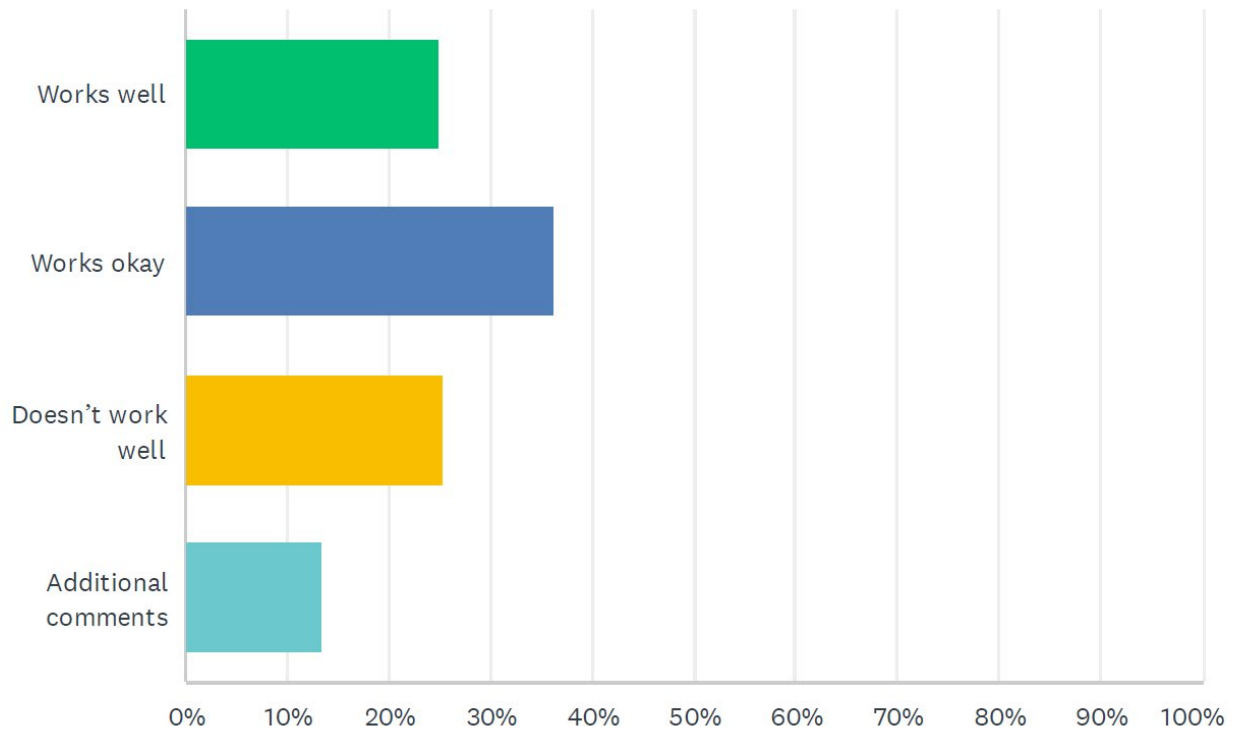
# Survey Summary

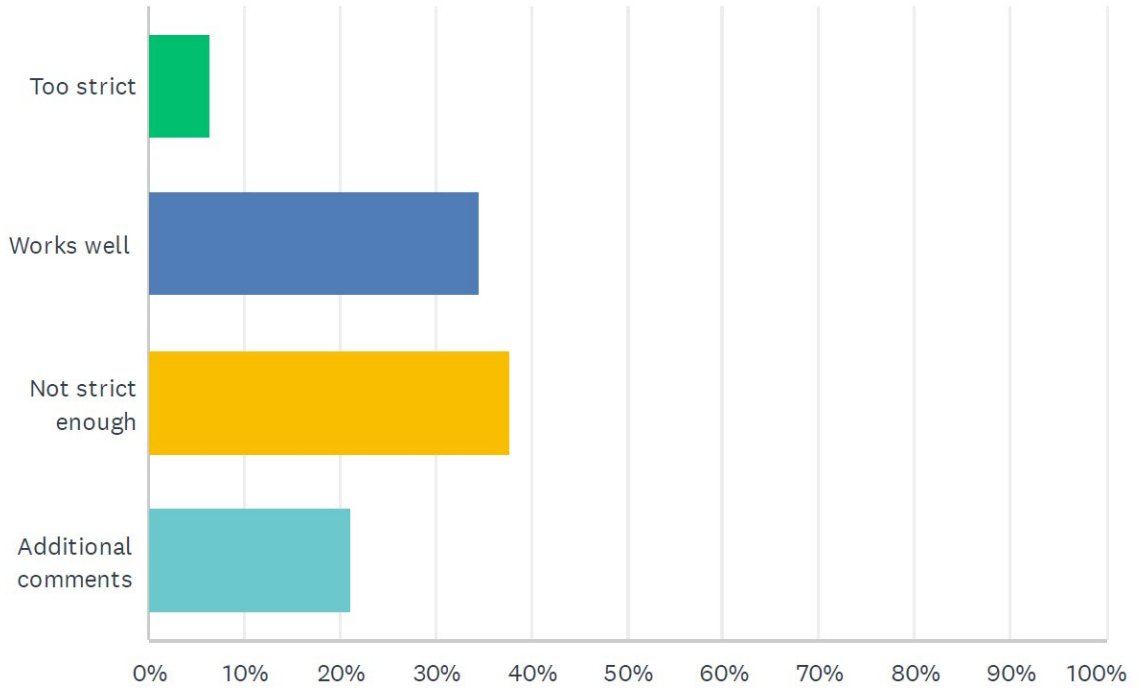
## Q1: How do you feel about the current Noise By-law?



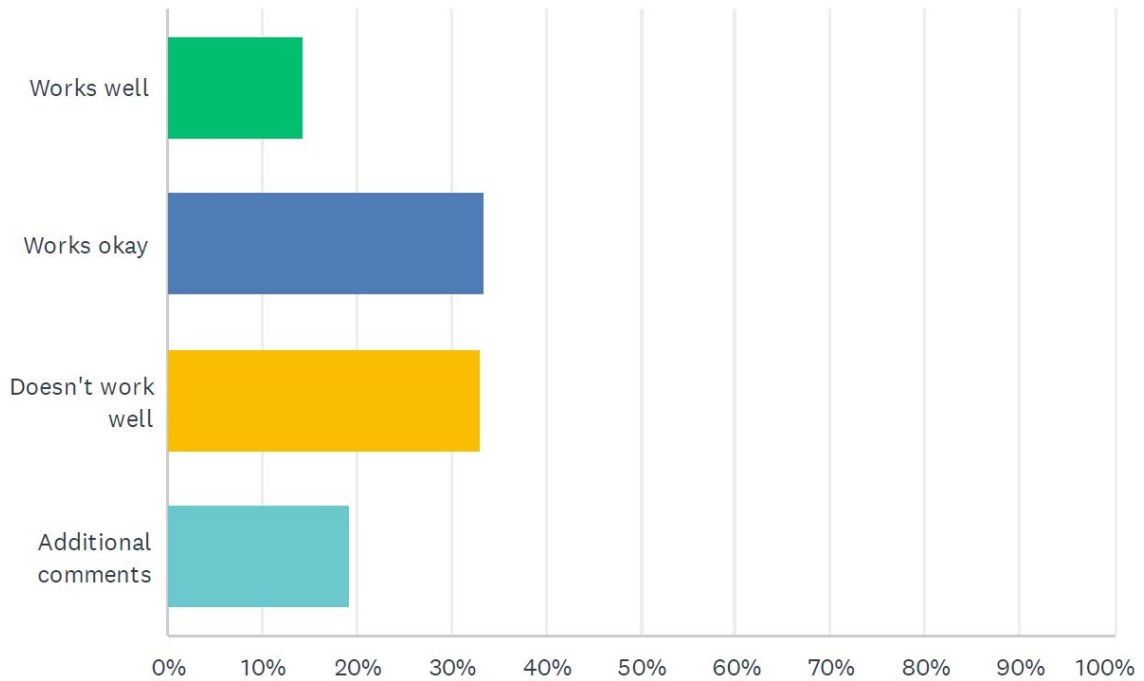
## Q2: How well does the current Noise By-law control noise disturbances in your area?



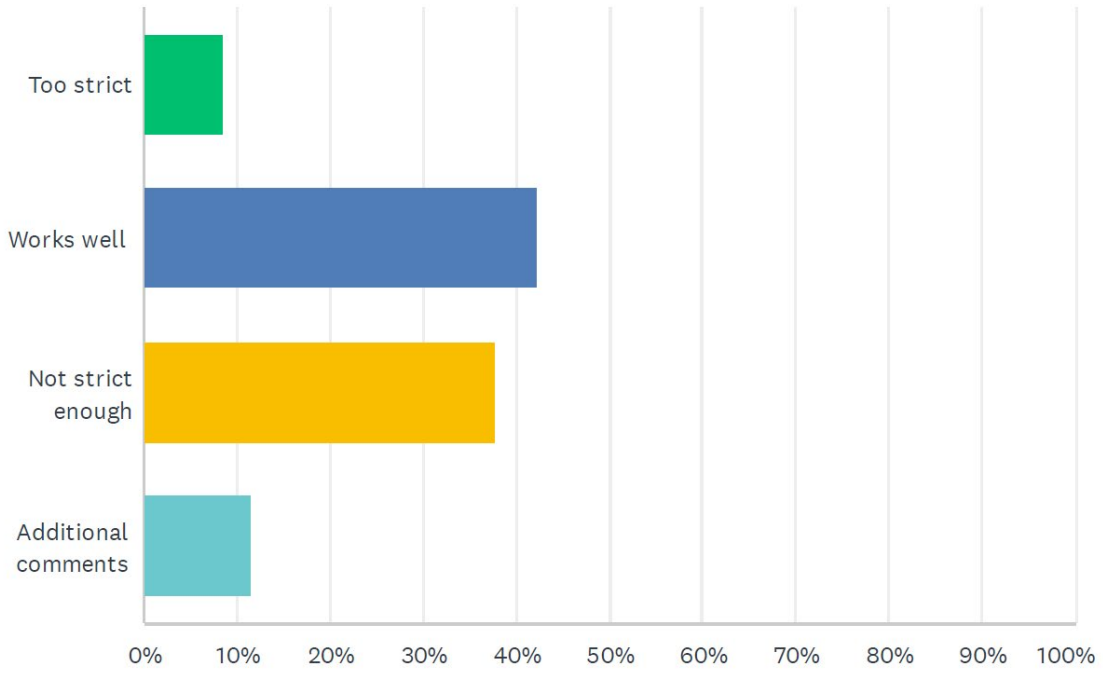
### Q3: How do you feel about the current Clean and Clear Yards By-law?



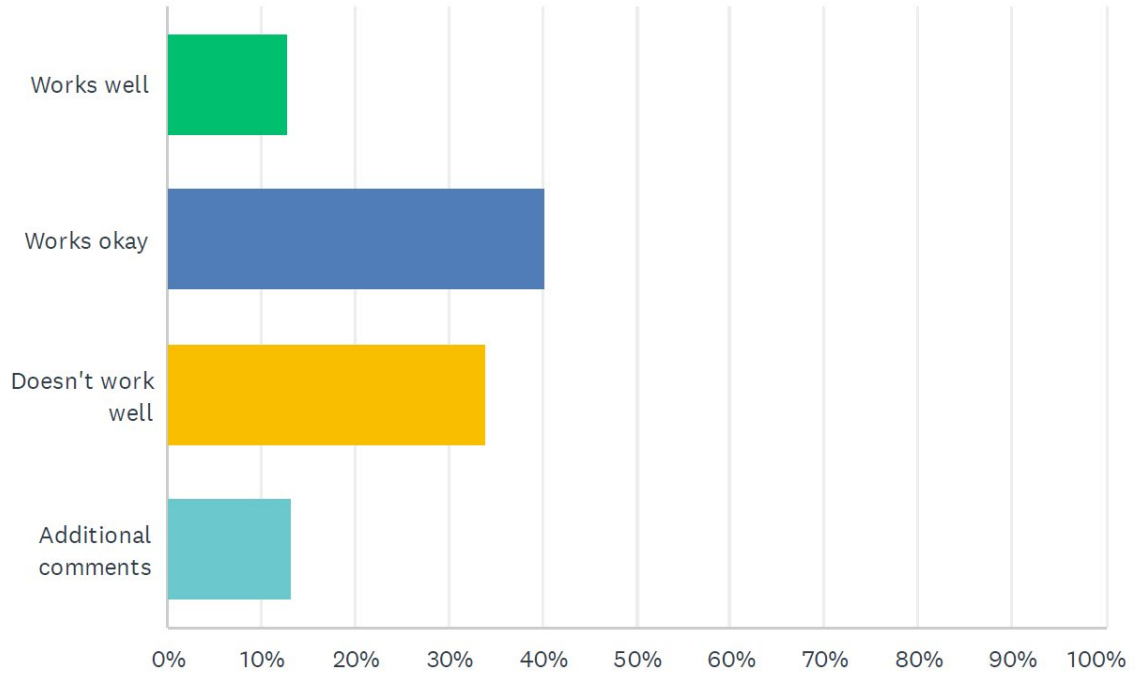
## Q4: How well does the current Clean and Clear Yards By-law help keep properties maintained in your area?



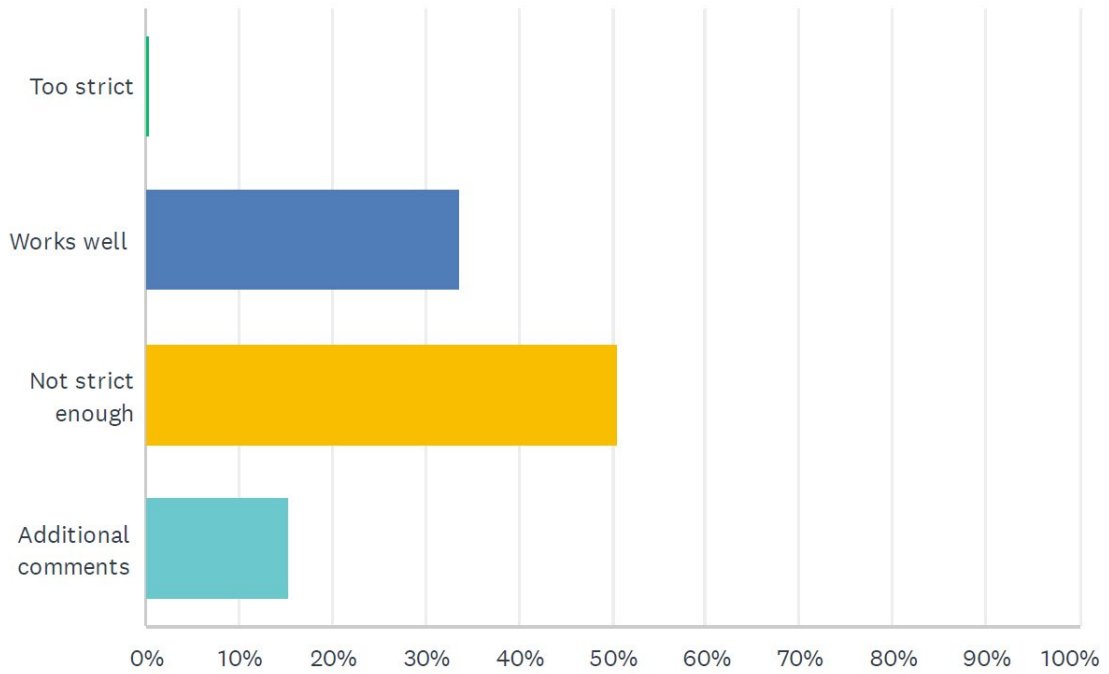
## Q5: How do you feel about the current Property Standards By-law?



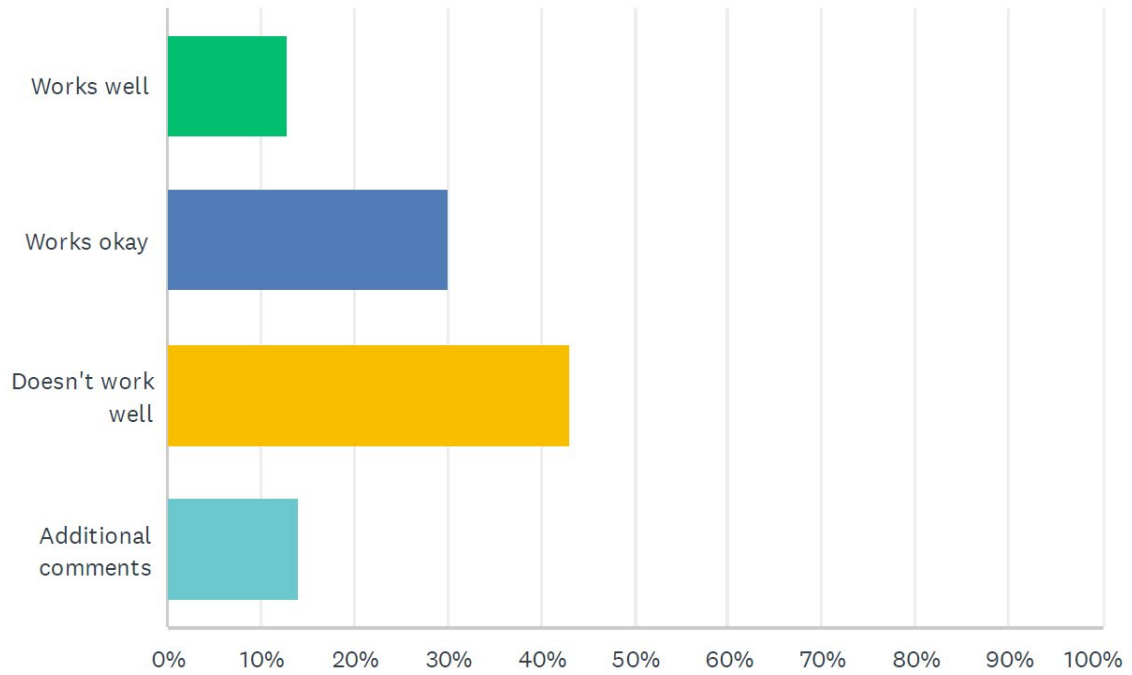
## Q6: How well does the current Property Standards By-law help keep buildings maintained in your area?



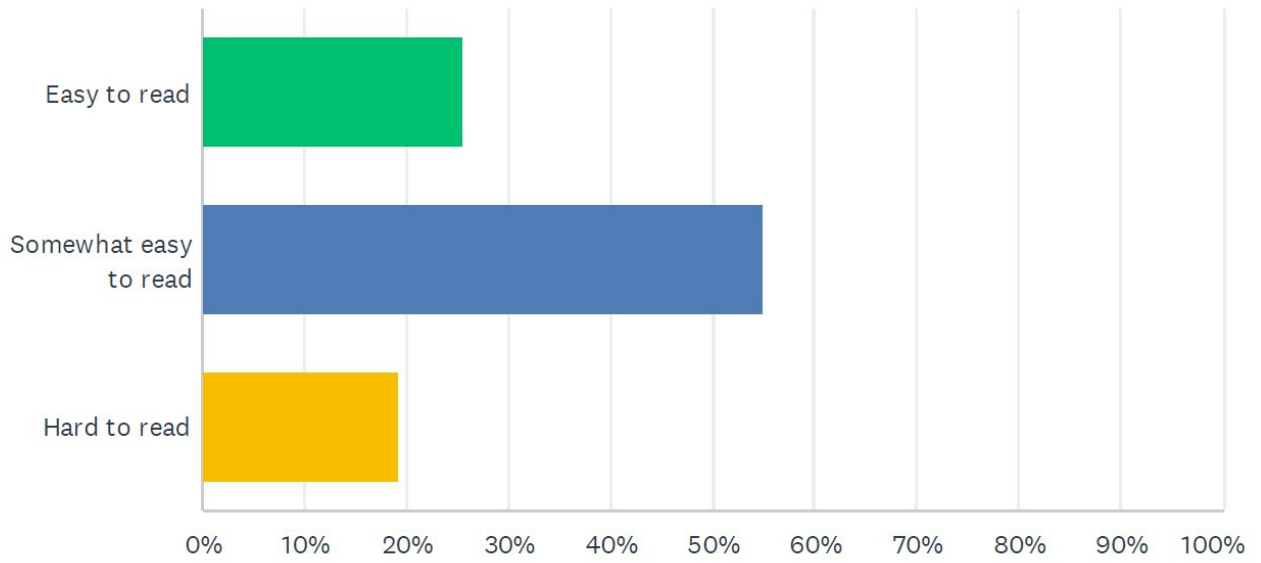
## Q7: How do you feel about the current Littering By-law?



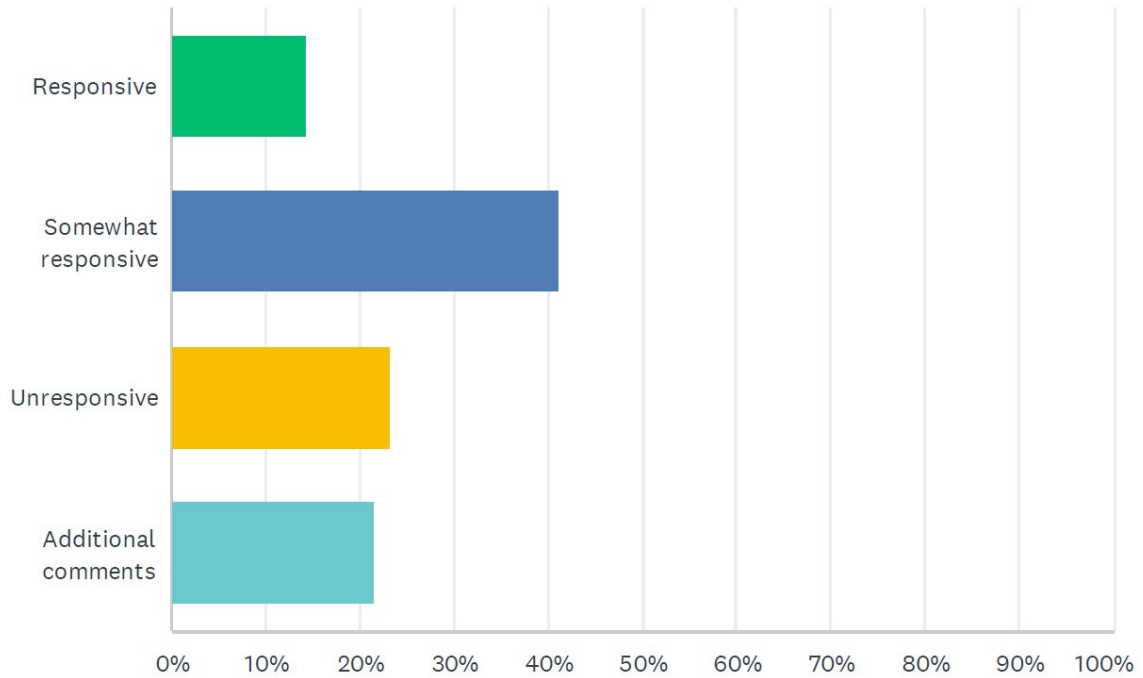
## Q8: How well does the current Littering By-law control littering in your area?



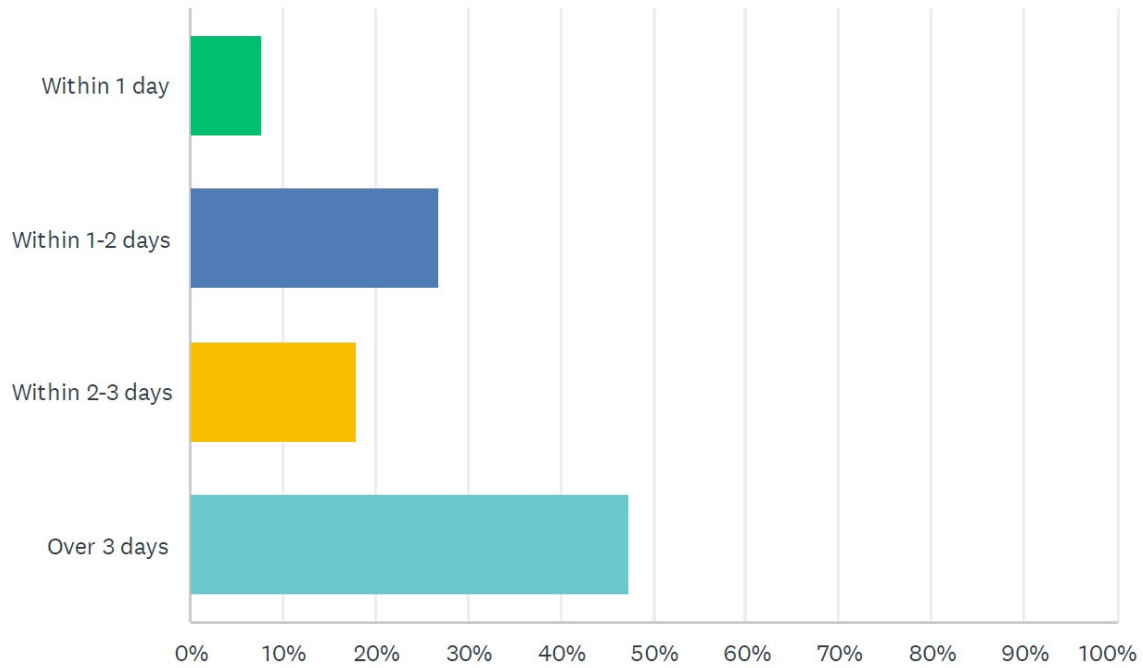
## Q9: How easy-to-read are the City's by-laws?

# Appendix A

Below is a detailed look at the responses from questions 1, 2, 3, 4, 5, 6, 7, 8 and 10 of the survey.

## Q1: How do you feel about the current Noise By-law?

- Increase more parking areas if you will not allow curbed parking year round
- You should reconsider parking bylaws
- Cars with modified exhaust are out of control.
- Too many noisy cars and trucks
- I have not had much experience with this bylaw
- Does not appear to include high powered car audio systems that shake adjacent vehicles
- Sorry, but you needed to put a synopsis of by-laws at the beginning of the survey. I am not inclined to ask for an emailed copy be sent to me. Hardly user friendly and certainly not confidential. This is a surprising flaw in your process.
- Don't know what it is now.
- Resident of Greater Napanee but very interested in your programs
- The world works 24/7. People that work night shift have to listen to all the noises during the day when they have to sleep, so doesn't make sense to restrict noise at any time.
- Fireworks on the streets for Diwali is dangerous.
- I don't know the law and haven't needed yet.
- Need longer when concerts are outside
- Excessive dog barking not enforced
- Haig Rd has become a speedway with some pretty loud vehicles
- NO FIREWORKS in subdivisions ever!
- Works well. I would like to point out that fireworks are bad for animals and military veterans and would like to see fireworks eliminated in the City.
- Stop changing things.
- Fireworks should be banned
- Bylaw is good, but no enforcement makes bylaw useless.
- With family homes now being used for rooming houses the tenants are not respectful to neighbours of family homes.
- People don't abide by them and yet nothing is done
- I don't agree with the restriction of noise through yard maintenance on Sundays and holidays. This is outdated.
- traffic noise from ridiculously loud vehicle exhaust systems, and heightened traffic volume
- Enforce the 24/7 noise by law! Especially for repeat offenders with disregard for their fellow neighbours who have children or employed! Current noise by-law not strict enough
- Please enforce with police during the night downtown
- Not strict enough around fireworks
- Definitely need a by law bit seldom gets enforced
- Rockfest outside of the Empire Theatre should not be allowed. There are other places in parks, etc where there aren't any residences available for that.
- Only works for certain people

- I have no actual knowledge or experience with noise issues other than loud mufflers so cannot give useful feedback on this issue.
- haven't really been exposed to the noise
- not strict enough, Difficult to find who you report to, City or Police, main page should have a list of contacts and what phone number to call for the various issues, should not have to search for this
- does not provide exception for regular play outdoors by kids
- do not know what the bylaw is
- loud loud bass radio anytime should be regulated
- I've never reported excessive noise or have experience with the by-law.
- Last year I contacted the city about a loud vehicle two doors from us and was instructed to contact the Belleville police about the issue. I contacted them but never did hear back on whether the issue was addressed or not. The vehicle is still loud.
- Not strict enough pertaining to nuisance dogs
- Start handing out tickets, and for repeat offenders slap them with higher fines
- It is extremely unclear
- When fireworks are going off at 2 am there is no "noise bylaw" enforced. Whats the point
- Every single day of the spring, summer, and fall, my neighbour has a radio playing loud enough to hear inside my house beginning most days before 6-630 and extending in to the late late evening. I've looked around for any rules or where to go or what to do and can't find anything. If there are by laws, how on earth are any of us supposed to actually find them and then what, pray that the city peice will actually do something? lol.
- Bylaw effectiveness requires that it be enforced!!!!
- Unnecessary loud exhaust on cars and motorcycles. you wouldnt know we have a noise bylaw
- Thinks it's a shame about no fireworks
- noise isnt a big issue in town
- Section 2 of the current bylaw is very difficult to quantify: "any noise that is likely to disturb". Also, not allowing chainsaws, chippers, and leaf blowers on Sundays is prohibitive. For many people, weekends may be their only time to perform this work, and Sundays may not be any more sacred than any other day.
- I opted to review the Noise By law but it wasn't emailed to me (all other bylaws were successfully emailed.. so unfortunately I cannot comment on this particular one)
- Fireworks on non allowed days is so easy to enforce. Fireworks can be seen miles away yet no police or bylaw officers arrest anyone. What's the use of a bylaw if not enforced.
- People need to be reminded about the early morning noise on a Sunday morning as there are people that do work shift work and this may be the only two days a week they can sleep-in.
- No one follows the noise by law when it comes to fireworks. We live north of 401 in the subdivisions and people just set them off whenever and do not care time or day.
- Specifically mufflers on cars that are extremely louder than original manufacturers settings!!!!!!!!
- Constant dog barking should be addressed
- We have a couple that fight none stop in building nothing gets done at all. Been dealing with g for 6 years and cops do nothing but come and leave and landlord does nothing
- Not experienced enough with it to provide feedback.
- Set times for work/ music/ etc...
- Should be earlier to those with neighbors that share walls ( apartments, townhouses..)
- I think repeat offenders get too many notifications before fines are given.
- details of current by-law unknown.
- Hours should be 10pm to 7am in the summer
- Vehicles with loud mufflers should be looked into more often
- There does not seem to be enough bylaw control over certain things like fireworks. Not only is this loud but also dangerous to set off in an urban environment and strict fines need to be given.

- People are working out of garages making horrible noise 7 days a week.
- Noise from construction sites should be limited to how long contractors are allowed to continue. i.e. Months/weeks
- Whatever happened to a quiet zone near hospitals??
- Would like it adapted to include chickens (no roosters), quail and possibly a turkey per household for personal consumption

- Rural so no issues

- We have hunters firing shot guns on the water in the fall.We live on the Bay of Quinte.Its very disturbing on Sundays
- We live in a quiet area and are not bothered by excessive noise
- We work shift work so the noise bylaw really doesn't help us.
- No noise issues in my neighbourhood
- Never really experienced any problems.
- Excessive dog barking not addressed
- Stop changing things.
- every morning and some afternoons certain homes with dogs let their dogs out, even in the dead of winter and the dogs are left out in the back yards and yap and yap and yap until the owner brings them in. Wakes up people who go to bed later and sleep in in the morning. (read Seniors )

- The [redacted] residents driving around with their music so loud it rattles windows in my house, my daughter can't even sit outside when she is visiting as the base from the JEEP causes issues with her pacemaker and the driver of the jeep drives down our street through the city parking lot and usually parks there and just play their music, he is also known to drive up and down the isles at Walmart.... Its insane, and not nice and can cause medical issues. I'd like to be able to sit outside with my children during the summer but we can't.
- No enforcement, enforcement without impact.
- Never been an issue in my neighborhood (Woodland Acres)
- It has worked well as all neighbours care, has never been a problem even before more stricter rules
- noise isnt a big issue in town
- Issue with noise with renovations; contractors not following by-laws.
- Many set off fireworks with no regard for time or day.
- Cars screeching at very late at nite or early am, racing, loud mufflers
- Dogs bark all day
- Its a quiet city, you dont even need this bylaw
- Not experienced enough with it to provide feedback.
- several summer evenings neighbours out in their yards until wee hours of the morning
- Very noisy neighbors outside all times of the night bylaw and police dont respond in time
- We dont have any issues in our area so I havent seen it applied
- There does not seem to be any stopping of fireworks by bylaw officers. This is not only a noise infraction but poses a threat to the health and safety of many neighborhoods when set off in urban areas.
- Dogs still bark, drug addicts coughing right outside our window all hours of the day and night.
- It allows irrational people to complain 24/7. There needs to be a time frame, loud after 10pm. And if a dog barks during the day for 5 min - it doesn't warrant a police call. They should be charged for wasting police resources. Now if a dog barks for an hour, that's a reportable issue. But this needs to be documented! Please update the noise bylaws. Timelines. No pound after 10pm and before 8am. Dog excessive barking for and hour. Not just anytime they hear a dog. It's ridiculous
- non existent. and trying to call the non emergency line at 0100 while the police are dealing with REAL issues... we need stricter enforcement

### Q3: How do you feel about the current Clean and Clear Yards By-law?

- Increase more parking areas if you will not allow curbed parking year round
- You should reconsider parking bylaws
- Needs better enforcement
- In the last 5 years the yards are not being kept clean, garbage bags and other debris. Property owners have taken less care in how their properties look. One home had rats due to garbage left piled up. More education in PSA's and By Law Officers leaving warning notes on doors.
- There does not always seem to be adherence since by law, and when it is obvious that properties are not maintained the property can stay that way for months before anything's done.
- who cares about lawn length?
- It took almost four years before neighbor(s) understood that by-laws were a "real thing". The fines and notices simply weren't efficient. Within a month it was ALWAYS back to the same condition--so began the continuous back and forth. We moved.
- It is essential that distinctions between owners and occupants/tenants be made and that each be held accountable for their respective faults and responsibilities.
- Just drive around and look at some yards.
- Needs a lot of attention
- Should not exist at all... I'd turn my yard into a butterfly preserve for monarchs in response to this. Pay around a million for my house I'd do what I want with my yard
- Gardeners should be permitted to experiment with naturalizing methods.
- With the "new" building rehabilitation many Landowners and or Landlords are Not being held responsible for property and waste maintenance and control drawing down neighborhood properties value and neighborhood appearance. happening increasing mult-unit and rentals, many Landowners/ Landlords are Not being held responsible for waste
- My neighbours to the north are disrespectful of any lawn or property cleanliness or Mtce. They don't cut their grass or shovel snow. There is garbage littered about the property. Currently there are two garbage bags sitting at the curb and they will sit there and blow all over the street until someone else deals with it. I have submitted many complaints through the portal and the City does follow through. However, it takes at least a month for resolution. It's the garbage on the back deck that is so offensive. Rats running through it and racoons. It's just awful
- For years uncut & untreated thick & very tall weeds in property on Tank Farm Road has been infecting the backyards 15 houses.
- not sure but my landlord fails on snow removal as I fell and received a knee slipping on Black Ice
- We are rural so that doesn't apply to farmers but I live residential
- I understand keeping properties looking nice is great but it's a big waste of time money and energy that could be better spent elsewhere. I get we don't want properties looking old and abandoned but at the same time we don't have any current laws for improving biodiversity and saving on Water and Gas and energy when it comes to cutting and maintaining all these yards and spots. There has to be a balance that we can find.
- The city needs to adhere to their own bylaw. i.e. the fairgrounds.
- flowers growing on lawn for butterflies, bees etc is great for pollination
- Absent landlords and too many [redacted] tenants in housing in residential neighborhoods!
- Not enforced at all on Spruce GDNS
- Don't know it

- Nice homes and grass not cut or garbage all outside
- Restrict too many vehicles parked on grass
- Works well "when someone decides to apply it"
- Neighbour does not keep yard to current standards and nothing being done after several complaints

[redacted] has been deeming brand new renovation materials as debris, has no knowledge of herbs and pollinator habits, has repeatedly gone against settled case law re keeping vehicles on ones property. - the regulation states lawns to be kept at a maximum of 15 cm, however, with many yards going more natural, this should change to allow for more natural yards to encourage insects and birds.

- Too many absentee property owners
- Lots of properties that rent to far too many people do not cut grass or even pick up garbage
- Depends who you are whether you get away with it or not
- in potters creek it is disgusting the weeds on the lawns, renters mostly
- Bylaw enforcement should not be complaint driven but rather beef up staffing and enforce via "drive by". In any case, it takes too long to get anything done and requires repeated complaints to get anything done.
- Russell Place has a black pickup truck parked & full of black garbage bags
- Belleville is becoming dumpy very fast

- Too strict for some people and took lax for other people some people get harassed and other people don't get bothered for anything in their yards

- Our city is a garbage dump. Rental properties [redacted] don't keep their properties clean
- Too many people leave garbage cans in front of their houses
- There should be more information listed about naturalization of lawns
- I should be permitted to have a wildflower lawn. Green lawns are not good for pollinators
- The City does not impose the regulations. I can drive around my own neighborhood and see at least 4 houses with terribly unkept and garbage filled yards. And that is the just what I can see on the front yard.

- There's a bylaw for this? There's trash and junk in yards all over the place in this town.

- We need to keep yards tidy, yes, but we also need to bring ourselves into present day where pollinators need safe havens. If people want to have pollinator patches, they should be allowed to, but to just keep them contained, off the sidewalk (not flopping over). People should be ENCOURAGED to create these safe havens for wildlife and pollinators to increase biodiversity and protect our dwindling insect populations. They are the bottom of the foodchain. Without our insects, we perish. Not everybody wants a chemical lawn. Lawns are monoculture wastelands. We need to think outside the box when it comes to people's front yards.. Pesticides and herbicides should be discouraged (ideally, they should be totally outlawed). Additionally, people should be encouraged to grow fruits and vegetables in front yards, or wherever the sun will allow.
- Too many messy and junky yards, especially in the mixed zone areas that have commercial and residential
- The By-law is not a problem, it's the reporting and enforcement that is lacking.
- I would like to be allowed to own chickens
- Need to enforce grass cutting and garbage cleanup and maintenance especially at [redacted] houses where there are way too many people living
- In my neighborhood of Hillcrest there are cars that are disabled stored on side yards, on the front lawns and boats as well. There are also canvas canopy garages erected that border on the sidewalk. Several properties have eliminated the front yards as there are several homes with 4-6 cars parked anywhere. For some reason in the past 6 months Liddle has had no parking signs erected on one side of the street. NOT sure why as overnight parking is not permitted. Time to ticket and tow.
- City plows should not be allowed to block driveways with snow. Not only is it insanely heavy to remove but half the time there's massive chunks of ice and snow inside. Make it illegal for city plows to block driveways.
- There doesn't seem to be enough enforcement. Citizens should not have to sign their names and have it given to the offending property owner. This just deters people from calling with their concerns. It's a safety issue to have your name given out. I don't understand how this is even allowed under the Privacy Act. Things used to be looked after very well. Not now.
- Is very strict. It does not allow for environmentally friendly stewardship of yards/properties, indicating that all vegetation needs to be cut to 15cm maximum, and should allow for composting of yard wastes if space is available, rather than confining wastes to bags/containers or transporting to other sites (while using fossil fuels). Also, 30 days to repair a personal vehicle that is unlicensed is prohibitive to many on a budget who would like to repair/restore a project car (it is reasonable though to limit to 1 personal vehicle only)
- not strict enough, most yards on my street are mowed once or twice per summer season with excessive vines and weeds growing
- Renters do not take care of their properties. Also fields for future development need to be enforced.
- Remove parked cars from front yards!
- Out of town owners of Rental properties do not make arrangements for lawn care
- There should be city staff keeping an eye on overgrown yards, junk put to the roads ect.
- The city should be held to the same standard. City owned property isn't maintained. Often grass is out of control and excessive litter
- Don't believe such a thing exists
- Works well but seems to require constant follow up
- Finding that homes that used to be private dwellings that are now rented are not being kept up to standard ie garbage, lawn maintenance etc
- My house, not yours unless it's a hazard none of your business
- Our neighborhood is a dump pile. Numerous city-run houses and joined dwellings repeatedly, repeatedly, and repeatedly pile their garbage and garbage bags around their residences bringing rats, mice, etc. absolutely appalling.
- too many people parking cars on their front yard. you have to complain no proactive enforcement.

- current by-law unknown,
- Should apply to vacant lots. Grass should be cut and garbage cleared.
- This needs to be enforced more and stricter
- Opener of neighboring property has never maintained property. Lawn & bushes never cut or trimmed. Piles of newspapers have been left in driveway for years! And courtyard has old bed mattress & tent that has been left for more than 5 years.
- Garbage in wooded areas from people that live around them. People throw yard waste over their fences.
- Sometimes not monitored enough
- Yard sale in Corbyville needs to be addressed.
- Just leave your crap out in your yard, it will disappear, guaranteed.
- I think it works well, if enforced. Our neighbours have a bunch of junk laying around, that noone does anything about.

#### **Q4: How well does the current Clean and Clear Yards By-law help keep properties maintained in your area?**

- I have had to call by law a few times due to un kept properties on my neighbourhood.
- Increase more parking areas if you will not allow curbed parking year round
- You should reconsider parking bylaws
- The city doesn't cut all the grass in our park at the south end. You would think they could set a better example.
- The homes are not being cared for and starting to look slum like neighbourhoods with cars on the lawns, ruts in the yards, garbage left for weeks. Home owners have lost interest and those who look after their home ... live next door home owners who don't care. It affects the investments of those who may want to sell or new home owners looking to move into our community.
- See above/ for the most part it works well, but when people do not comply with it, it appears that nothing is done by the city.
- i still dont care
- Sometimes it works -- sometimes it just doesn't.
- Many infringements on these bylaws are caused by tenants over which owners have no control and therefore these bylaws and enforcement have no effect other than to unduly burden the owner.
