BY-LAW NUMBER 2022-179

A BY-LAW TO PROVIDE FOR FEES AND CHARGES

THE COUNCIL OF THE CORPORATION OF THE CITY OF BELLEVILLE ENACTS AS FOLLOWS:

WHEREAS Section 391 of The Municipal Act, 2001, permits a municipality to pass By-Laws imposing fees and charges for services and activities provided or done by or on behalf of it and for the use of its property;

AND WHEREAS the Council of The Corporation of the City of Belleville desires to revise some existing fees or charges and impose some fees and charges for services and activities provided by the City, its officers or employees, or for the use of some or all of the City's properties;

NOW THEREFORE, the Council of The Corporation of the City of Belleville enacts as follows:

1. **THAT** the fees and charges set out in Schedule "A" attached to this By-Law shall apply to every request made to The Corporation of the City of Belleville and City departments or any officer or employee of the City, including but not limited to fees or charges for requests for documents, reports, letters and other information whether written, printed or electronically produced or stored or produced or stored in any other manner, searches, inspections, applications, permits, programs and the use of its facilities or properties, or for any other service or activity provided by the City to any person or any other authorized costs payable by the City;
2. **THAT** Schedule "A" shall be deemed to form a part of this By-Law;
3. **THAT** all fees listed in the attached Schedules, where applicable, will be subject to Harmonized Sales Tax (H.S.T.);
4. **THAT** should any provision of this By-Law including any provision contained herein be determined by a court of competent jurisdiction to be invalid or void and of no force and effect, it is the stated intention of Council that such invalid provision shall be severable and the remainder of this By-Law shall continue in full force and effect;

5. **THAT** By-Law Number 2021-195 and any and all other by-laws inconsistent herewith are hereby repealed on the date this By-Law comes into force, provided that any request made prior to the date of passing made for information, an application for a permit, an inspection or any other request for a service or activity provided by the City as contemplated in this By-Law shall be governed by the fees and charges contained in the By-Laws set out above;
6. **THAT** this By-Law shall be known as the “Fees and Charges By-Law”;

THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT ON **JANUARY 1ST, 2023**.

Read a first time this **12th** day of **December 2022**.

Read a second time this **12th** day of **December 2022**.

Read a third time and finally passed this **12th** day of **December 2022**.
